This Appeal is filed under Section 44 of the Real Estate (Regulation And Development) Act, 2016 before the Karnataka Appellate Tribunal, Bengaluru, to set aside the order dated 22<sup>nd</sup> July 2019 in CMP/190226/0002199 passed by the Adjudicating Officer, RERA-respondent-1. **JUDGMENT**

Smt. Ruthika for M/s AKS Law Associates, learned Counsel appearing for the Appellant, fairly submits that the matter is already covered by the judgment of this Tribunal dated 08.01.2020 passed in Appeal (KREAT) No. 126/2020 (Old RERA Appeal No. 164/2019) (Parkway Homes LLP Vs. Vishaka Priyadarshini & another), and prays for disposal of the appeal in terms of the said judgment.

Sri M V Prashanth learned Counsel appearing for Respondent No.1 submits that in the light of the above judgment of this

Tribunal, the appeal does not survive for consideration and it may be dismissed.
