Matter is taken up before National Lok Adalath for conciliation. On behalf of the Complainant-Geetha Singh D and on behalf of Respondent-developer/promoter Proprietor Sri Dinesh Kumar, rep: R.K. Constructions.

The parties to the litigation have amicably settled the matter in the following terms:

- The respondent has agreed to the repay a sum of Rs.68,00,000-00 (Rupees Sixty eight Lakhs only) on or before three months from 1-4-2022 ending 31-06-2022 with no interest to the complainant through Demand Draft.
- In case, if the respondent commits default in making repayment as agreed above then the Complaint is entitled to get 10% p.a. interest on the agreed amount of Rs.68,00,000-00(Sixty Eight Lakhs only) from 1-7-2022 till date of full realization payable by the respondent.
- The Complainant shall have to withdraw the Consumer Complaint No.425/2021 which she has instituted against this respondent before the District Consumer Disputes Redressal Commission at Bengaluru soon after she receives the full repayment as cited above from the respondent.
