On behalf of the Complainant-Shankar H.R. and on behalf of respondent-developer/promoter Godrej Reserve LLP (earlier known as Sai Srushti Onehub Projects LLP) for project Godrej Reserve Phase-2 by its authorized representative viz., Nisha Mohan.

The parties to the litigation have amicably settled the matter in the following terms:

- The respondent has agreed to the repay a sum of Rs.12,05,979-00 (Rupees Twelve Lakhs Five Thousand Nine Hundred and Seventy Nine only) within a period of 60 days from today with no interest to the complainant through Demand Draft.
- In case, if the respondent commits default in making repayment as agreed above then the Complainant is entitled to get 10% p.a. interest on the agreed amount of Rs.12,05,979-00 (Rupees Twelve Lakhs Five Thousand Nine Hundred and Seventy Nine only) till date of full realization payable by the respondent.
- The Complainant shall have to withdraw all claims with respect to the said transactions against the respondent upon realization of the sum.
