1. During the pendency of the above complaint, the complainant/allottee and the respondent/promoter after due deliberation have got their dispute pertaining to the subject matter of the complaint settled amicably before the Lok-Adalat.

4. On 27/04/2023 Rs. 1,55,412/-



The opposite party is liable to pay Rs. 10,000/- towards cost of the litigation to the complainant towards the said case.

Both parties to the proceedings have no claim whatsoever against each other in respect of the subject matter of the above complaint.
