

JOINT MEMO

The complainant and the respondent in the above complaint jointly submit as under:

1. During the pendency of the above complaint, the complainant/allottee and the respondent/promoter after due deliberation have got their dispute pertaining to the subject matter of the complaint settled amicably before the Lok-Adalat.

2. In view of the same, they jointly request this Lok Adalat to dispose of the complaint as amicably settled before the Lok Adalat in the following manner.

1. On 29/11/2022 Rs. 95,000/-
2. On 26/12/2022 Rs. 95,000/-
3. On 25/01/2023 Rs. 95,000/-
4. On 25/02/2023 Rs. 95,000/-
5. On 25/03/2023 Rs. 95,000/-
6. On 25/04/2023 Rs. 1,05,000/-
7. On 25/05/2023 Rs. 1,05,000/-
8. On 25/06/2023 Rs. 1,25,000/-
9. On 25/07/2023 Rs. 1,25,000/-
10. On 25/08/2023 Rs. 1,21,160/-

Total amount of Rs.10,56,160/- (Ten Lakh Fifty Six Thousand One Sixty Rupees) infavour of the complainant through RTGS/NEFT as a full and final settlement amount towards the said case. Incase of non payment of monthly payment 2% interest shall be payable by the respondent to the complainant. The opposite party is liable to pay Rs. 10,000/- towards cost of the litigation to the complainant towards the said case.


