JUDGEMENT/ORDER

1. This complaint is filed under section 31 of the RERA Act by "GM INFINITE SILVER SPRING FIELD " developed by "M/s GM INFINITE DWELLING(INDIA) PRIVATE LIMITED" for the relief of directions to the respondent to complete the project, formation of Resident Welfare Association, BWSSB connection, refund of car parking charges, compensation for delay, mental agony and unfair trade & other reliefs etc.
2. On 27/11/2023, both the complainant and respondent have filed memo of withdrawal stating that they have arrived into an mutual understanding in settling their differences. Accordingly the complainant has decided to withdraw the complaint herein as settled amicably between the parties in all respect. Hence the complainant has prayed this Authority that he may be permitted to withdraw the complaint by reserving the liberty in the interest of justice and equity.
3. In view of the facts, the memo dated 27/11/2023 filed by the complainant is taken on record. Hence the following order.
